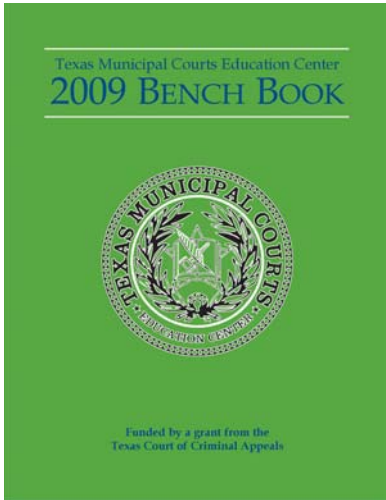


TMCEC Bench Book (2009)
