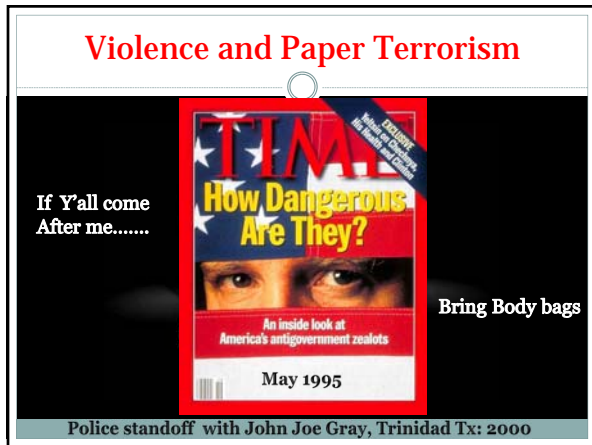

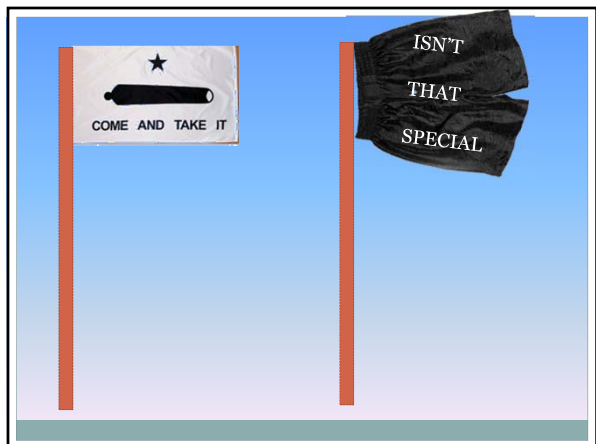

- Pseudo authority used to confront Court and govt. officials
- Challenging language with anti-government foundation
- "script" of questions and scripted responses.

## Planning and Presentation

- Courtroom appearance is planned (video & crowd)
- Courtroom presentation is planned (scripted) and may be accompanied by numerous documents addressing the theories of the Sovereign Citizen
  - The flag may be an issue
  - Demands for oaths of the officials
  - Constitutional claims (1<sup>st</sup>, 2<sup>nd</sup>, 5<sup>th</sup>, etc)
  - Authority of Court is rejected (the Sovereign Citizen is the authority) verbal conflict, ignoring minor courtesy

## Planning and Presentation



1. Know what to look for and evaluate everyone.
2. Know the applicable law
3. Be patient (frustration, anxiety and time will be used against you )
4. Be Safe
5. Be Vigilant

Law of the Clerk

- Gov. Code 29.002 A City Court is established in each City
- Tx Constitution Article 5 sec 1 provides for establishing other courts as required
- Govt. Code 29.010  
"The clerk shall keep the minutes, issue process, and generally perform the duties for the Municipal Court that a County Clerk performs for a County Court."

## County Clerk Manual (on Line)

### 1. What must I file in Municipal Court?

- Distinguish between "Instruments for recording" and "Court Instruments."
- Recorded instruments generally deal with real property – liens, deeds, abstracts, UCC financing statements,

## Can I "Unfile" a Document

### 2. What if I file a document and then think it is fraudulent?

- Govt code 51.109
- Within 2 business day of receipt of filing, notice
- Shall request assistance of the County or Dist Atty. Govt Code 51.901(d)  
This assistance can be requested prior to filing; with additional request to the filer for supporting data.

## If a Fraudulent Lien is filed on a Court Official

### 3. If you or a court official are targeted by fraudulent lien filings:

- Govt Code 51.903 file w/o cost a Motion for Judicial Review in Dist Ct.
- Tx Practice and Remedies 12.002 damages, exemplary damages, atty fees.
- Consider Bus and Commerce Code sec 17.44 Deceptive Trade Practices.

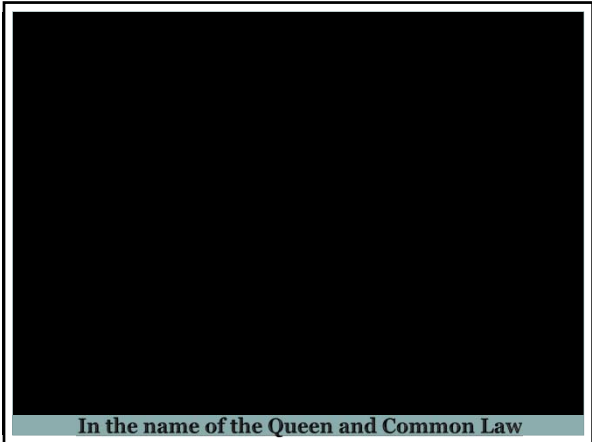
