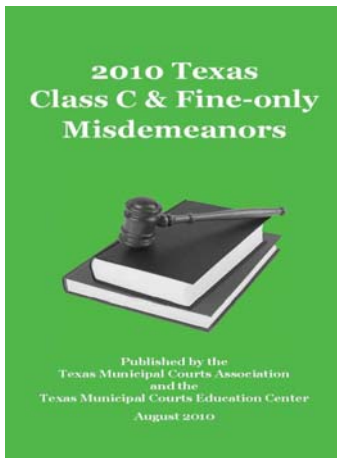
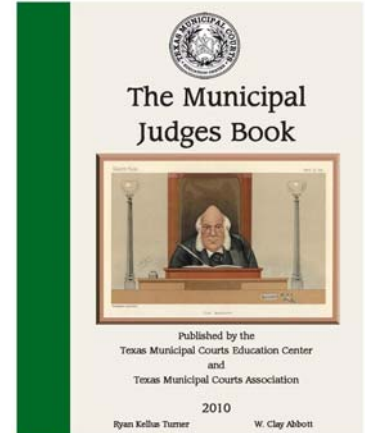

The *Texas Class C and Fine-only Misdemeanors* handbook (the "Green Book") represents a comprehensive effort to compile all Class C, fine-only criminal offenses under State law. Covering 25 codes and containing roughly 1,400 offenses, it includes statutory cites for both the offense and penalty provision, the fine or fine range for each offense, DPS reporting codes for those offenses that have assigned codes, and notes for those offenses that are enhanceable or for which circumstances would heighten the punishment category. A new appendix contains the list of moving violations promulgated by DPS in the Texas Administrative Code.
