

### NOT EVERYTHING IS TICKET-FIXING

Number Of Dallas Police Who Issued Tickets For 'Not Speaking English' Grows

A story that began with one woman's complaint to a TV station about the ticket she'd been given by police "for being a non-English speaking driver" has mushroomed in Dallas.

As the *Morning News* reports: "since 2007, at least 20 Dallas police officers from five patrol divisions have wrongly cited motorists for not speaking English."

The newspaper says the number of officers involved "is likely to grow because Dallas police officials say they plan to look back several more years and include the supervisors who signed off on the tickets in the investigation for possible dereliction of duty."


WFAA-TV says that 39 people received such tickets. All but one were Spanish speakers. The 39th was issued to a Vietnamese man.

The city is going to drop any of the cases that are still pending and will reimburse anyone who has paid a fine for the fictitious violation.

#### Largo suspends police chief

Largo's internal investigation revealed a dizzying web of friends doing favors for friends of friends.

A passenger in Werthman's car contacted Largo dispatcher Amanda Wormhood to see if she could get the citation dropped.

Wormhood, who was off-duty, asked another dispatcher to contract Citrano to see if he would fix the ticket, but that dispatcher didn't follow through. Then Officer John Sinni, who was with Wormhood, called or texted Citrano, who was driving a woman to a breath testing facility on suspicion of driving under the influence.

Citrano was recording the woman during the transport as part of routine procedure so when he returned Sinni's call, his side of the conversation was captured on tape.

"I already submitted the ticket," Citrano can be heard saying on the tape, "but if you say it's a friend you want me to try to extend some courtesy, what I'll do is I'll delete it ... just void it,"

Two days later, Citrano sent a request to the court asking that the ticket be voided. He said he meant to issue a warning but a citation was automatically generated by a computer glitch. The ticket was dismissed July 8.


**EL PASO, Texas --** The El Paso County Sheriff's Office released new information Friday about the arrest of a deputy for allegedly abusing his power.

Sgt. Hector Montes was arrested on a charge of official oppression after he allegedly offered to fix a woman's ticket in exchange for sexual. Police said the scene was caught on tape.

"This is clearly not what we stand for, it's a black eye on our organization, but I hope the citizens understand that this is something we will not tolerate," said Sheriff Richard Wiles. "And we took swift action, and I hope the citizen's understand that they can trust us."

Montes has been placed on paid administrative leave and Wiles said they have started the process to fire Montest as early as next week.

#### Alleged 'Ticket Fixer' Facing 20 Years

One of the six Nassau County Traffic and Parking Violations Agency employees that were fired last month for allegedly fixing tickets was arrested Tuesday, according to Nassau County District Attorney Kathleen Rice.

Angela Petty, 41, of Freeport, was charged with 10 counts of tampering with public records, 10 counts of falsifying business records and 10 counts of official misconduct. She faces up to 20 years in prison, if convicted. She pleaded not guilty at her arraignment and is being represented by Legal Aid.

Petty was a clerk in the agency since 2005 who earned \$38,952 annually for entering case dispositions into the agency's computer system after defendants appeared in court. She was fired on August 11.

Between August 2007 and July 2008, Petty helped her daughter and another relative avoid paying 10 fines by altering records in the system so that the tickets appeared to have been dismissed, the district attorney said. She made it appear that specific judges had formally dismissed the tickets on specific dates, but made sure that the tickets never made it before those judges, Rice said.

"Ms. Petty violated the public trust and abused her position to benefit her family members," Rice said in a statement. "My office takes these crimes very seriously and we will continue to arrest those who help themselves

to the detriment of Nassau County taxpayers. The fact that there exists a line for those with connections and a separate line for those playing by the rules is intolerable and, in my book, it's criminal."

#### Benzie County prosecutor faces hearing

BEULAH -- A state attorney grievance board filed a complaint against Benzie County Prosecutor Anthony Cicchelli for ordering the dismissal of his stepson's speeding ticket.

The Michigan Attorney Grievance Commission served Cicchelli with a formal complaint Oct. 10, said commission attorney Cynthia Bullington. The complaint alleges Cicchelli committed "professional misconduct" by ordering a magistrate to dismiss a speeding ticket issued to his stepson, Larry Marshall Hoffman, 21.

#### 2 more judges reprimanded in ticket-fixing cases

The Dakota County judges were reprimanded by the state Supreme Court for their outside-the-courtroom handling of traffic tickets for a former clerk.

Two more Dakota County judges were publicly reprimanded on Thursday by the Minnesota Supreme Court for their handling of traffic tickets for a former clerk.

That brings to three the number of Dakota County judges who have been found to have violated judicial standards this year. In all three cases, the judges were accused of settling cases for people they knew without telling a prosecutor.


#### RECAP
