

Hill v. State

A *Batson* motion or objection that the opposing party made a peremptory strike based upon race is timely so long as it is made before the jury is impaneled and sworn. In *Hill*, the Court of Criminal Appeals held that the appellant timely objected after the peremptory strike list had been delivered and the stricken venire members had been excused, but before the jury was sworn.
