## Faculty Acknowledgment and Release

**Presentation Development and Delivery** – You are aware that TMCEC maintains a webpage for faculty members [<http://www.tmcec.com/Programs/Faculty>]. The webpage not only contains information on preparing and delivering successful presentations, it also articulates mutual expectations between TMCEC and faculty members before, during, and after the delivery of the presentation.

**Vendors and Service Promotion** – You are aware Rule 6.11 of the TMCEC Board of Directors prohibits TMCEC from using public monies to endorse, recommend, or imply approval of vendors. Some TMCEC faculty members are self-employed or employed by law firms, collection agencies, consulting firms, court security companies and other businesses that are vendors and that provide services to municipal courts and/or municipalities. As a faculty member, you agree to refrain from making remarks while speaking at TMCEC events that constitute prohibited promotion or endorsement of your own business interests and/or those of third parties. Neither grant conditions nor Board policy prohibits TMCEC faculty members from using their job title or professional affiliation during their presentation, in course materials, from passing out business cards, or setting up exhibits at TMCEC events.

**Written Materials** - You retain the individual copyright to your written material, allowing you to freely sell or otherwise distribute it and revise or republish it at will. TMCEC owns a copyright to the collected work in which your material will appear. Submission of your material grants TMCEC a nonexclusive license for TMCEC's benefit to reproduce, sell, and otherwise distribute all or portions of your material under your name, individually or as part of collective and derivative works, through any media now known or that might be created.

**Live Presentations** - You retain the individual copyright in your live presentation, allowing you to freely present and revise subsequent presentations at will. TMCEC's owns the copyright to its electronic capture of your live presentation. Giving your presentation grants TMCEC a nonexclusive license for the TMCEC's benefit to reproduce, sell, and otherwise distribute all or portions of your presentation (including any audio/visual aids incorporated therein) under your name, individually or as part of collective and derivative works, through any media now known or that might be created.

**Materials Copyrighted by Third Parties** -Your use of copyrighted material is a representation by you to TMCEC that you have obtained the rights necessary to such material for the benefit of the TMCEC with respect to the nonexclusive licenses described above.

**Reimbursement** – You have been provided a copy of what is and is not reimbursable by TMCEC. You understand that TMCEC's reimbursement policy is determined by the Texas Court of Criminal Appeals. Effective September 1, 2011, reimbursement expenses incurred in relation to serving as TMCEC faculty must be sought no later than 60 days from the date of travel.
